Subject: - Request for the functioning of all the sanctioned EMRS from Academic Year-2024-25 - reg.

Dear Sir/Madam,

This letter is to draw your kind attention towards the matter of the 09 sanctioned EMRSs in respect of your state that have not yet been made operational.

As you are well aware that Ministry of Tribal Affairs have been establishing EMRSs across the country with the aim of providing quality education to the children belonging to the tribal communities. The delay in the opening of sanctioned EMRSs is causing significant inconvenience to the students who are eagerly waiting to avail of the facilities offered by these schools.

In this regard, it is requested to look into the matter, take necessary steps and immediate action to ensure that these 09 sanctioned EMRSs are made functional from Academic Year-2024-25 irrespective of the fact whether construction work is complete or in progress or yet not started.

Further, the schools where construction work is in progress or yet not started, those schools have to be made functional in Other Government Buildings/ Rented buildings. The children from the tribal communities have limited access to quality education, and these schools will be a great help in bridging this gap.

The list of schools that are non-functional is enclosed herewith as **Annexure I** for your reference.
